the day and night, but are particularly annoying in the dark hours when said residents are attempting to sleep; now therefore,

Be it resolved by the Plain Township Board of Trustees, Stark County, Ohio, as follows:

Section 1. This Board hereby determines that the use of an engine brake on a motor vehicle causes the motor vehicle's motor to race in such a manner as to cause its exhaust system to emit a

loud, cracking, or chattering noise unusual to its normal operation, and by this regulation hereby prohibits such use in the vicinity of 55th St. from East of Lindford to West of Harmont.

This regulation does not apply to "emergency vehicles" or "public safety vehicles" as defined by ORC Section 4511.01.

Section 2. Whoever violates the prohibition set forth in Section 1 above is guilty of a minor misdemeanor.

Section 3. The effective date of this resolution shall be ten (10) calendar days after the posting of signage appropriate to carry out the purposes of this Resolution.
